January 2<sup>nd</sup>, 2013 – The Division approved the 112 Construction Materials Reclamation Permit. The amount of the financial warranty set by the Division for this operation was \$68,574.00.

October 15<sup>th</sup>, 2013 – The Division sent the operator a notice that the financial and performance warranties had not been received and would need to be submitted by January 2, 2014.

February 11<sup>th</sup>, 2014 – Pursuant to Construction Materials Rule 1.6.1(2), the Division mailed notices to the Operator and the county in which the proposed operation is to be located.

March 5<sup>th</sup>, 2014 – The Division received proof the Operator initiated the Public Notice Procedures outlined in Construction Materials Rule 1.6.

**STAFF RECOMMENDATION:**

Re-affirm the Division approval of the Construction Material Regular 112 Operation Reclamation Permit Conversion Application for the T Bone Quarry, DRMS File No. M-2004-030 and require that the appropriate financial and performance warranties be posted on or before January 2, 2015.

**Corrective Action(s):**

Require the Operator to submit the appropriate financial and performance warranties in an approvable form on or before January 2, 2015.
