OBSERVATIONS

The inspection was conducted by Elliott Russell of the Division of Reclamation, Mining and Safety (Division). Steve Williams of Washington County was present for the inspection. The Cecil 11-34-49 Pit is located approximately 4 miles north of Cope, Colorado. The site is permitted for 9.8 acres and the post-mining land use is rangeland. This inspection was carried out as a part of the Division's routine monitoring inspection program.

At 11:25, the Division and Mr. Williams arrived at mine entrance along County Road 11. At the time of the inspection it was sunny and the ground was dry. The mine site identification sign was observed at the entrance. Mr. Williams had stated that the material remaining to be mined is no longer suitable for county operations and the pit would be reclaimed.

Topsoil had be stripped and piled in two different locations; one pile along the east side of the pit and the other was on the north side. A recent excavation was observed during the inspection. Mr. Williams believes this was caused by someone other than the landowner or Washington County. He stated that the county had not taken any material from the site for a few years. If the Applicant is concerned that more illegal mining may occur once the county grades the slopes for reclamation, the Division recommends either installing a locked gate at the entrance or posting a sign stating reclamation is in progress and not to disturb.

The boundary corners were in place and marked with t-posts. An area, approximately one acre in size, was observed south of the southern permit boundary which appeared to be disturbed, but naturally vegetated. Mr. Williams had stated this area may have been disturbed before the permit was originally issued.

In the 2014 Annual Report, received April 17 2014, Washington County indicated that the date of last excavation, processing or hauling activity occurred in June 30, 2010. As per Rule 3.1.1, all reclamation shall be carried to completion within five years from the date the Operator informs the Division that mining is complete. Washington County has until end of June 2015, to finish reclamation or the Division may pursue enforcement actions.
