On April 24, 2014, the Division of Reclamation, Mining and Safety (Division/DRMS) received a notice from the Pueblo County Department of Planning and Development, explaining that the special use permit associated DRMS Permit No. M-2002-009 has been declared abandoned (Pueblo County Special Use Permit No. 2001-001). It is the operator's responsibility to maintain the county special use permit if operations occurring within the permit boundary require a county special use permit. If the operator plans on continuing operations that require a county special use permit, the operator must obtain a county special use permit and provide proof to the Division that a special use permit has been obtained.
