Dear Travis,

Oldcastle SW Group, Inc. dba United Companies would like to request a technical revision to modify our DRMS permit for the Virginia Acres site.

At our March 12, 2014 DRMS site inspection it was noted that our re-vegetation efforts at the Virginia Acres site have been unsuccessful in many areas and a new plan must be implemented to insure the site reclamation plan succeeds. Our goal is to have the site fully reclaimed and released from DRMS oversight by the end of 2016. United Companies has retained the services of Paul Schreiner to help us develop the plan, seed mix and oversee the reclamation efforts in addition to his previous weed control efforts. The Technical Revisions provides a timetable and describes our reclamation efforts.

- A) United Companies will conduct a site visit with our consultant to determine the areas where reclamation efforts have failed. **DONE**
- B) United Companies will bring in sufficient equipment to the site to re-work the soil in preparation of re-seeding this coming fall.
- C) The seed mix will be reviewed by our consultant and approved by DRMS prior to seeding the site.
- D) The site preparation work will be completed by October 30, 2014
- E) The seeding will occur in late fall (November 30th) to achieve optimum results.
- F) In the spring of 2016 a site visit will be scheduled with DRMS to review the results.
