Re: **Permit Issuance** Permit Renewal No. 4 (RN-4) Carbon Junction Mine (Permit No. C-1992-080)

Dear La Plata County Commissioners:

The Colorado Division of Reclamation, Mining and Safety renewed Mining Permit No. C-1992-080 for the Carbon Junction Mine on June 10, 2014, allowing coal mining and reclamation operations to continue under the provisions of the Colorado Surface Coal Mining Reclamation Act of 1979. The permit was issued to Oakridge Energy, Inc., 4613 Old Jacksboro Highway, Wichita Falls, TX 76302-2921, (940) 322-4772, for their mining operation located in La Plata County, approximately 2 miles Southeast of Durango, Colorado. The permit area is further described as follows:

A tract of land located in Section 4, Township 34 North, Range 9 West; Section 33, Township 34 ¹/₂ North, Range 9 West; and Section 33, Township 35 North, Range 9 West; of the New Mexico Principal Meridian, La Plata County, Colorado, and being more particularly described as follows:
