The Division of Reclamation, Mining and Safety (Division/DRMS), has completed a preliminary review of the 112 Construction Materials Reclamation Permit application, and has the following comments.

APPLICATION FORM:

1) Please post a notice at the entrance of the mine site that displays the information required by Rule 1.6.2(1)(b). After posting the notice, please provide a signed affidavit stating the notice has been posted and/or include a photograph of the notice. Please see the attached affidavit.

2) Please have the maps signed by a registered land surveyor, professional engineer, or other qualified person as required by Rule 6.2.1(2)(b)

6.4.4 EXHIBIT D - Mining Plan

- 3) Part a: The Division would request that the Operator/applicant commit to seeding any topsoil stockpile that will remain in one location for longer than a growing season.
- 4) Part e: Please remove or clarify the statement about a 23 acres floating bond.
- 5) Please specify if explosives will be used in conjunction with the mining (or reclamation). In consultation with the Office, the Applicant must demonstrate pursuant to Subsection 6.5(4), Geotechnical Stability Exhibit, that offsite areas will not be adversely affected by blasting.1

6) Please have the map signed by a registered land surveyor, professional engineer, or other qualified person as required by Rule 6.2.1(2)(b).

6.4.19 EXHIBIT S - Permanent Man-made Structures

- 7) Where the mining operation will adversely affect the stability of any significant, valuable and permanent man-made structure located within two hundred (200) feet of the affected land, the applicant may either:
 - a. provide a notarized agreement between the applicant and the person(s) having an interest in the structure, that the applicant is to provide compensation for any damage to the structure; or
 - b. where such an agreement cannot be reached, the applicant shall provide an appropriate engineering evaluation that demonstrates that such structure shall not be damaged by activities occurring at the mining operation; or.
 - c. Where such structure is a utility, the Applicant may supply a notarized letter, on utility letterhead, from the owner(s) of the utility that the mining and reclamation activities, as proposed, will have "no negative effect" on their utility.

- 8) Please provide proof of publication in the local newspaper as required by Rule 1.6.5. Proof of publication may consist of either a copy of the last newspaper publication, to include the date published, or a notarized statement from the paper. An application may not be approved until such proof has been obtained.
- 9) Please provide proof of mailing or serving all Owners of Record of the surface and mineral rights of the affected land; and the Owners of Record of all land surface within 200 feet of the boundary of the affected lands, as required by Rule 1.6.2(1)(e).
- 10) Please address the attached comments from the State Historic Preservation Officer.
- 11) Please address the attached comments from the Colorado Division of Water Resources.
- 12) Please see the attached comments for the Colorado Parks and Wildlife.

Thank you for your correspondence dated May 22, 2014 (received by our office on May 27, 2014) regarding the subject project.

A search of the Colorado Cultural Resource Inventory database indicated that no cultural resource inventories have taken place in the vicinity of the proposed project area and no historic properties have been recorded within the subject property. However, our files contain incomplete information for this area, as most of Colorado has not been inventoried for cultural resources. As a result, there is the possibility that as yet unidentified cultural resources exist within the proposed project area.

Should human remains be discovered during the proposed project activities, the requirements under State law C.R.S. 24-80 (part 13) apply and must be followed.

CONDITIONS FOR APPROVAL

The proposed operation does not anticipate exposing groundwater. Therefore, exposure of ground water must not occur during or after mining operations. If stormwater is contained on-site, it must infiltrate into the ground or be released to the natural stream system within 72 hours, or all work must cease until a substitute water supply plan, or augmentation plan approved by water court, is obtained. Reclamation plans must ensure water will not be retained onsite for more than 72 hours unless an augmentation plan approved by water court is obtained.

COMMENTS: According to the application, no water will be used and no ground water or surface water will be disturbed during mining operations.

Thank you for the opportunity to comment regarding the application from Huerfano County Government for the proposed Peak View Gravel Pit. The proposed gravel pit will consist of 40 acres and is located in the NW ¼ of the NW ¼ Section 9 and in the NE ¼ of the NE 1/4 of Section 8, T29 S, R 68 W, 6th P.M., Huerfano County, State of Colorado.

After visiting the site it appears that the current use of this land is for grazing of livestock. There are no riparian corridors in close proximity to the proposed site. Colorado State Highway 160 and Huerfano County Road 520 are heavily traveled and border the proposed site on the south and west.

Big game species that frequent the area include elk, mule deer, black bears, mountain lions, and pronghorns. A resident herd of pronghorns use this area for reproduction purposes, feeding, and travel corridors. A herd of 400 plus elk winter on Silver Mountain Preserve and calf along County Road 520 in late May and June. Numerous small game animals are found in this area, which include but are not limited to, red fox, swift fox, coyotes, bobcat, cottontail rabbits, black-tailed prairie dogs, and badgers. Various songbirds, raptors, and reptiles are also present in the vicinity of the proposed Peak View Gravel Pit.

After reviewing the maps and document for the proposed site CPW does not foresee significant impacts to wildlife or wildlife habitat. Highway 160 and County Road 520 produce large volumes of traffic and noise. The loss of grasses for feed and the interference of travel corridors for pronghorn and elk will have minimal impact with a site 40 acres in size. To our knowledge there are no known Threatened or Endangered species within or in close proximity to the project site. We would suggest that any ground disturbance be reclaimed to native grass species, and recommend using NRCS seeding guidelines.
