Please be advised that on August 18, 2014, Lincoln County, whose address and telephone number are P.O. Box 39, Hugo, CO 80821; (719) 743-2337, filed an application to convert M-1978-078, Pickenpaugh Gravel Pit, a 110(c) Limited Impact Construction Materials Permit to a 112(c) Regular Construction Materials Permit. The mining and reclamation operation is located at or near Section 14, Township 14S, Range 58W, 06th Prime Meridian, in Lincoln County. The application decision is scheduled for November 17, 2014.
