**Re: New Horizon North Mine (Permit No. C-2010-089)
Technical Revision No. 7 (TR-7)
NHN-001 East and West Ditch As Builts**

Dear Sir or Madam:

The Division of Reclamation, Mining and Safety hereby issues notice, in accordance with Title 34, Article 33, Section 116, Paragraph 4, of the Colorado Revised Statutes, that on September 15, 2014 an application to revise coal mining operations at the New Horizon North Mine was considered complete for the purposes of filing. The revision was submitted by Western Fuels-Colorado, LLC. All review and comment periods as provided in the Act and the Regulations initiate from this date of filing.

This revision provides as-built information for the East and West Ditches that flow into Pond NHN-001. This is in response to Notice of Violation CV-2014-004. This violation was given because the as-built documentation does not accurately replicate observed ground conditions regarding the construction of the ditches. The applicant is not proposing additional surface disturbance outside of the area currently approved for disturbance.

The surface coal mining operation is on land located approximately 2.5 miles Northwest of Nucla. The permit area is further described as follows:

Portions of Sections 25 and 36, T 47 N, R 16 W, N.M.P.M.

The above-mentioned tracts of land are shown on the following USGS 7.5 minute Quadrangle map(s): Nucla.



Because the above referenced technical revision application may incorporate additional lands into the permit area or might otherwise alter previously approved permit conditions or mitigation measures, the Division is coordinating with the Office of Surface Mining on evaluation of the potential for impacts to threatened or endangered species of plants or animals, or wildlife species otherwise protected by federal law. A copy of the permit section addressing potential effects of the operation to threatened and endangered (T&E) species has been forwarded to the Office of Surface Mining. The OSM will prepare any biological assessment necessary for approval based on the information provided in the application, and OSM will coordinate with your office as necessary. This coordination is required to ensure mitigation of potential impacts to federally protected wildlife species.

The applicant is required to publish notice in the *San Miguel Basin Forum* that this application has been deemed complete. At the time of publication of this notice, the applicant is additionally required to place a copy of this application at the Montrose County Courthouse, 300 Main Street, Nucla, CO 81424, and at the Division office. In order for us to comply with regulatory time frames, we request that comments be submitted within ten (10) days of this letter.
