In the June 19, 2014 letter, instruction for compliance was given: **"IN ORDER TO AVOID PERMIT REVOCATION, PLEASE SUBMIT \$323.00 FOR ANNUAL FEES DUE AND \$323.00 FOR CIVIL PENALTIES ASSESSED (FOR A TOTAL OF \$646.00, AND YOUR ANNUAL REPORT BY July 25, 2014."** We are in receipt of your 2014 Annual Fee, Report, and Map for the above-referenced permit as referenced in a Notice of Violation MV-2014-015 Civil Penalties, and Cease and Desist Order.

In the August 1, 2014 Notice of Violation Letter, instruction for compliance was given: **"IN ORDER TO AVOID PERMIT REVOCATION, PLEASE SUBMIT \$323.00 FOR ANNUAL FEES DUE AND \$323.00 FOR CIVIL PENALTIES ASSESSED FOR A TOTAL OF \$646.00 AND YOUR REQUIRED ANNUAL REPORT BY SEPTEMBER 22, 2014."** At this time, the 2014 2013 Annual Fee (\$323.00), Report, and Map, and the \$323.00 Civil Penalties remain outstanding and are due.

This matter is now scheduled for the September 24, 2014 Board Meeting for consideration of permit revocation and forfeiture of your financial warranty. If we receive the Civil Penalties by Monday, September 24, 22, 2014, this will be withdrawn from the Board agenda.
