

Steamboat Springs, CO 80477, (970) 870-5552, has filed an application for a Construction Materials Limited Impact (110) Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The Proposed mine is known as the Big Red Park Gravel Pit, and is located at or near Section 22, Township 11N, Range 85W, 6th Prime Meridian.

The proposed date of commencement is September, 2014 and the proposed date of completion is September, 2024. The proposed future use of the land is U.S. Forest Service Land.
