PUBLIC NOTICE

Luke the Duke, LLC, whose address is 920 County Road 120, Hesperus, CO 81326 and phone number is (970) 759-9977, has filed an application for a Construction Materials Limited Impact (110) Reclamation Permit with the Colorado Mined Land Reclamation Board under provisions of the Colorado Land Reclamation Act for the Extraction of Construction Materials. The proposed mine is known as Luke the Duke and is located at or near Section 26, Township 35 N, Range 11 W, NM Prime Meridian.

The proposed date of commencement is July 1, 2014 and the proposed date of completion is July 1, 2017. The proposed future use of the land is agricultural.






