## **OBSERVATIONS**

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (DRMS). Celina Akin with American Soda, LLP accompanied the inspector during the inspection. The American Soda Yankee Gulch Minerals Project is located 22 miles southwest of Meeker, Colorado in Rio Blanco County.

The purpose of the site visit was to inspect the status of the operation and to observe the current conditions of the mining project.

The site is in final reclamation and the only activity other than reclamation that is occurring is environmental monitoring and site maintinance. On July 22, 2008 and amendment to revise the post mine land use for the process plant area was approved. The Division highly recommends that the operator removes the process plant from the permit area through an acreage reduction request in compliance with the requirements of Rule 4.17.

Due to the plugging and abandonment of multiple wells south and east of the access road the operator plans to demo and remove the surface product transport pipelines.

No problems or possible violations were identified during the inspection.




