On September 29, 2014, the Division of Reclamation, Mining and Safety (Division) received a Referral Request from County of Elbert regarding the Ardrey Effluent Storage Transfer Facility Project Application that was submitted to County of Elbert by Danny Paul Ardrey Estate Trust, landowner of the proposed project area. The proposed project area is adjacent to an active sand and gravel mine (Elbert County Pit; Permit No. M-1985-129) permitted by the Division for 38.69 acres. The Division has reviewed the information provided by County of Elbert, and has the following comments:

The 4.6-acre area that appears to be the proposed area for this project was released from the permit area of Elbert County Pit through an Acreage Reduction request approved by the Division on July 26, 2007. This released area includes the access road off of Elbert Road and a small pad area just south of the road where a small tank and a pile of asphalt waste are currently present.

The Operator of Elbert County Pit, Hudick Excavating, Inc., shall be responsible for reclaiming disturbed land within the permit area.
