**Re: Deep Creek Pacer, Permit No. M-1986-102; Temporary Cessation Notice; Financial Warranty Increase, SI-02**

Dear Mr. Collins:

The Division of Reclamation, Mining, and Safety received your notice of Temporary Cessation on September 27, 2013. Unfortunately I just became aware of your notice. Sorry for the delay in response. The Division is unable to process your notice of Temporary Cessation due to the following issues:

1. The notice of Temporary Cessation must be submitted to the Division on the enclosed notice form. Please fill out the form and return it to the Division.
2. B-Mining Company was notified of an increase in Financial Warranty on April 17, 2009. (See enclosed letter). A site cannot be put into Temporary Cessation status until the bond is adequate. The deadline for submitting an additional warranty when there is an increase is 60 days. The deadline for submittal is excessively expired. Please submit the additional bond amount of \$4,497.00 within 60 days of this notice to avoid enforcement action.

**YOU HAVE 60 DAYS FROM THE DATE YOU RECEIVED THIS LETTER TO POST THE ADDITIONAL AMOUNT**

The Division has not denied your request for Temporary Cessation and you have paid the fee for the revision. But the Division cannot approve it until the above issues are addressed. If the financial warranty is not received in the allotted timeframe, your request for cessation will be denied and enforcement action will be taken.
