OBSERVATIONS

This was a routine inspection conducted by the Division as part of its monitoring of Construction Materials 112c permits, and in response to the operator's request for an inspection to discuss current earthmoving activity. The operator named on page one was present throughout the inspection. In addition to the operator, also present during the inspection was Daryl Couch of Crossfire Aggregate. The site was active on the day of the inspection.

The required permit ID sign was observed posted at the entrance to the permitted area. [Note: the permit number on the sign is for a previous permit that was at the site. The operator must or replace the permit ID sign to reflect the correct permit number.] Permit boundary markers were installed along the permit boundary, which in most places was a fenceline.

All current activity is adjacent to the pond in the eastern portion of the site. The pond area has been defined, and further excavation in this part of the permit will not enlarge the pond surface. The operator wishes to remove a thick layer of overburden on the west and north sides of the pond, in order to expose and excavate the underlying aggregate, and then backfill that excavated area with the excavated overburden. There is no shortage of overburden in the permitted area, and it was agreed that this deeper excavation followed by backfilling up to the grade of the land surrounding the pond is in compliance with the mining plan. Some additional overburden is being moved to a location on the north side of the pond, in order to create a higher bench for the eventual placement of a building there. All slopes will still conform to the details of the approved reclamation plan.

The operator also wishes to change the elevation of reclaimed strip of land lying along the south side of the pond. It was graded, topsoiled and mulched as a level surface at the same elevation as the adjoining field to the south. The operator wishes to construct a permanent berm across the south side, for visual and noise mitigation, by placing excess overburden there. It will be graded to 3:1, topsoiled, seeded and mulched as the reclamation plan requires. This is also a minor change to the grading plan, but is in conformance with the overall specs of the reclamation plan, so it does not require a revision and it is not a problem. The operator is reminded that the slope gradients must not exceed the limits in the reclamation plan, sediment must not pass outside the permit boundary (please use sediment controls), and topsoil protection must be ensured through prompt seeding and weed control.

The excavation of aggregate is proceeding westward, and as the western river terrace is excavated and processed, the lower-elevation area (level with the land around the pond) is expanding. Topsoil is being salvaged and is stockpiled, or replaced wherever possible. The upper processing and stockpile area on the west is not yet disturbed by excavation. The operation is being carried out in an orderly manner. There is no disturbance to the separate, northern portion of the permitted area.

The operator stated that noxious weed control is being carried out in an effective manner, and that the thistle patch noted previously is being controlled.

There were no problems noted at this time. This office appreciates the operator requesting an inspection and onsite discussion of the current earthmoving.
