Dear Mr. Siglin:

On July 24, 2015 the Division of Reclamation, Mining and Safety approved the modification application submitted to the Division on December 31, 2014, addressing the following:

*To collect a one time prospective bulk sample of up to 200 tons from the Hansen Uranium Deposit via hydraulically jet cutting a cavern of rock from within a drill hole.*

Pursuant to Rule 5.1.3(d)(IV), The Office's determination shall not take effect until the expiration of the five (5) business days [after this Notice of Decision as required by Rule 5.1.3(d)(I)], allowed for an appeal or, in the case of an appeal, until the Board issues its decision.

The revised estimated liability amount of \$176,936.00 exceeds the \$154,936.58 performance bond currently held. Please submit additional bond in the amount of \$21,999.42 ONLY after the five (5) business days allowed for an appeal has expired or, in the case of an appeal, until the Board issues its decision. The modification will not be final until the bond is approved by the Division.
