The Division of Reclamation, Mining and Safety (DRMS) is in the process of reviewing the above referenced application in order to ensure that it satisfies the requirements of the *Colorado Mined Land Reclamation Act* (Act) and the associated *Mineral Rules and Regulations of the Colorado Mined Land Reclamation Board for Hard Rock, Metal, and Designated Mining Operations* (Rules). During review of the material submitted, the Division determined that the following issue(s) shall be adequately addressed before the application can be considered for approval.

# Exhibit F - Reclamation Maps

Item no. 25 addressed the original concern with a revised map F-1, after reviewing the map the contours still display a slope that is steeper than the required 3H:1V. Please provide a map that has revised contours that are no steeper than the required 3H:1V.

# Exhibit G - Water Information

Adequacy issue no. 28 intended to address the issue by providing table G-1. Table G-1 was not provided in the response. Please provide table G-1.

### Exhibit L - Reclamation Cost

Item no. 44 the response submitted intends to address the issue by providing revised pages L-2, L-7 and E-5, page L-2 does not provide any information with regard to backfilling and page L-7 was not provided. Please provide an adequate response that addresses the issue.

Item no. 45 intends to address the issue by providing the revised pages L-4, L-5 and L-9; page L-9 was not provided. Please provide page L-9.

### Exhibit T - Environmental Protection Plan

Item no. 49 addresses the adequacy issue regarding the direction of drainage of the concrete apron by providing a revised page T-26. The revised page T-26 does not provide any information that clarifies the drainage direction of the concrete apron and completely omits any description whatsoever. Please provide a revised page T-26 that adequately addresses the original adequacy issue.

Please submit your response(s) to the above listed issue(s) by August 10, 2015, in order to allow the Division sufficient time for review prior to the August 14, 2015 decision date. If additional time is required to respond to the issues a request to extend the decision date must be submitted no later than August 10, 2015 or the application may be denied. The Division will continue to review your application and will contact you if additional information is needed.
