Dear Mr. Nathan Hewes:

Per the phone conversation on August 11, 2015 Nathan Hewes requested that the Division of Reclamation, Mining and Safety (Division) send him the attached two forms for a Technical Revision and Financial Warranty Release. Directions and a general outline of what is required for each are as follows:

Request for Technical Revision (TR) Cover Sheet

- Complete the cover sheet.
- Permittee/ Operator information will be the Kirk Eberl.
- Description needs to say something to the extent of changing your mining plan to allow for a max disturbance of ### acres which is less than the current 184 acres allowed
 - For DRMS both actively mined land and reclaimed land awaiting release count as disturbed. (Example: 8 acres actively mining and 10 in final reclamation awaiting release is a disturbance of 18 acres.)
 - o Routt County may only see actively mined land as needing to be less than 10 acres.
- Attach a revised map depicting your phases of mining and proposed direction.
- Attach the fee of \$216

Request for Full or Partial Release of permit Area/ Surety Reductions

- I have already checked the Surety Reduction box for you.
- Finish completing the packet
- Include a new estimate of the actual cost to reclaim the site based on what it would cost an independent contractor to complete the reclamation.
 - O Needs to be itemized and meet the requirements of the reclamation plan

Once the forms are competed by Nathan Hewes:

- Send the forms to Mr. Eberl for final approval and submission as he is still considered the contact for the permit until a Succession of Operator can be completed.
- Technical Revision sent separately using standard USPS mail.
 - o Include TR form, Map and fee



- Surety Reduction must be sent separately using certified mail per Rule 4.17 and include:
 - o Include certified mail # on request form
 - o Mr. Eberl needs to sign page 2
 - o Include reclamation estimate.

Looking forward

The Division will review the requested TR for completeness when received with the fee. If the items are complete they will be considered filed. Once filed the Division has 30 days to determine if the requests is approvable. If more information is required a letter will be sent identifying deficiencies that need to be addressed. A decision will be made at the end of that 30 day review period or sooner if possible. A letter will be sent to the operator of the Division decision regarding the TR.

Prior to making a decision on the TR the Division will conduct a required inspection. Staff will recalculate the bond based on site conditions and to reflect the changes addressed in the TR request. A separate letter will be sent notifying the operator of the new bond amount and the staff's supporting calculations.

At that point the Surety reduction request can be made and approved after the required period. Once the technical revision and surety reduction processes have been completed the Succession of Operator process can be initiated.

The Division acknowledges that the items mentioned above are in an effort to move towards the required succession of operator. The Division is willing to extend the date of compliance, October 6, 2015, for resolving the Right of Entry issues as long as documentation demonstrating progress is being made is sent to staff.
