Dear Mr. Petch:

The Division of Reclamation, Mining and Safety hereby issues notice, in accordance with Title 34, Article 33, Section 116, Paragraph 4, of the Colorado Revised Statutes, that on September 4, 2015 an application to revise coal mining operations at the Munger Canyon Mine was considered complete for the purposes of filing. The revision was submitted by CAM Mining, LLC. All review and comment periods as provided in the Act and the Regulations initiate from this date of filing.

TR-26 incorporates the requested changes by DRMS to the Munger Canyon Mine's permit as part of the Midterm No. 7 process. The applicant is not proposing additional surface disturbance outside of the area currently approved for disturbance.

The underground coal mining operation is on land located approximately 18 miles North of Loma, Colorado. The permit area is further described as follows:

18 miles North of Loma, Colorado in Munger Canyon (mine site) and 1/2 mile east of Loma (rail loadout site)

The above-mentioned tracts of land are shown on the following USGS 7.5 minute Quadrangle map(s): Howard Canyon, Garvey Canyon, Mack.



Because the above referenced technical revision application may incorporate additional lands into the permit area or might otherwise alter previously approved permit conditions or mitigation measures, we are requesting your agency's evaluation of the proposal. Your comments and concerns relating to the adequacy of fish and wildlife resources information, the fish and wildlife plan, and the reclamation plan as it relates to fish and wildlife considerations, including potential impacts to threatened or endangered species, are requested. If wildlife habitat is the proposed postmining land use, we request your evaluation of any changes to proposed woody plant stocking levels, planting arrangements, and methods for mitigation of potential adverse impacts.

A user's guide for our imaging system is also available in pdf format at the same web address. Please advise us if you require additional information.

The applicant is required to publish notice in a local newspaper that this application has been deemed complete. At the time of publication of this notice, the applicant is additionally required to place a copy of this application at the Mesa County Clerk and Recorder, 200 S. Spruce Street, Grand Junction, CO 81501, and at the Division office. In order for us to comply with regulatory time frames, we request that comments be submitted within fifteen (15) days of this letter. If no comments are received by then, we will proceed on the assumption that you have no concerns with, or objections to, the applicant's proposal.
