OBSERVATIONS

This inspection was conducted as part of the normal program established by the Colorado Division of Reclamation, Mining and Safety. The Clifton Water Gravel Pit is located approximately 6 miles east of Grand Junction, Colorado in Mesa County.

The pit is currently not active and in final reclamation. The purpose of the inspection was to observe the reclamation success and to observe vegetation establishment.. The site was graded exceptionally well and the reclaimed slopes tie into the adjacent undisturbed slopes in a very natural looking way. All reclaimed slopes appear to be no steeper than the required 3H:1V. The pond area makes for a wonderful wildlife habitat with well established wetland vegetation species.

Based on the conditions observed during the inspection a request to release the entire permit area(s) is recommended. The Operator must submit a request that meets the process requirements of Rule 4.17. Rule 4.17 states the request must be sent via certified mail, include the address and phone number of all owners of property and such request shall state that the operator has achieved all requirements of the approved reclamation plan.

If this request is submitted within 60 days of this inspection report, the October 5, 2015 inspection can be considered the release inspection.




Road to Pump Station to Remain Permanent





