OBSERVATIONS

This inspection was conducted as part of the normal program established by the Colorado Division of Reclamation, Mining and Safety. The Tri County Pit is located approximately 1 mile northeast of Hotchkiss Colorado in Delta County. The site can be accessed from the Back River Road.

The purpose of the inspection was to observe the reclamation success and determine if the July 23, 2015 request for partial release of the reclamation permit was approvable. Based on the conditions observed during the inspection the 5.50 Acres requested to be released has been granted. The site was graded exceptionally well and the reclaimed slopes tie into the adjacent undisturbed slopes in a very natural looking way. All reclaimed slopes appear to be no steeper than the required 3H:1V.


Noxious weeds appeared to be under control and visibly dead. There were some kochia present, but is considered a pioneer species and is not out of control.
