Mail ballots back now to be counted

STATEWIDE – The 2015 Colorado election process is underway and the United States Postal Service is urging citizens to mail back ballots now to ensure every vote is counted.

According to state law, county clerks and recorders must be in possession of the ballot no later than the close of polls on Tuesday, Nov. 3. Only ballots received by that date will be counted.

A postmark does not count.

Earlier this month, millions of ballots were mailed to registered voters by election authorities.

USPS District Manager Selwyn Epperson, who oversees mail operations for the state, says Colorado postal employees are ready for the return of those ballots. "We've already processed thousands of ballots and are delivering them to the clerks and recorders in Colorado's 64 counties, "said Epperson. "The Postal Service anticipates a large influx this week and we are ready to ensure each and every Colorado vote is counted this year."

As a reminder, all ballots require postage and in some instances extra postage is necessary because of weight.

There are also drop off locations in each county which are specified on ballot instructional material.

"The Postal Service has served a role in the very fabric of this nation for two and a half centuries," said Epperson. "We are honored to be part of the Colorado Election process."

Wild Horses Slaughtered in Mexico

Southern Colorado rancher Tom Davis sold nearly 1,800 wild horses for slaughter; New Mexico-based livestock business questioned

A Colorado rancher just over the New Mexico state line sold a Mexican slaughterhouse nearly 1,800 wild horses he had bought from the Bureau of Land Management, and Southwest Livestock Co., in Los Lunas, NM, was asked if it played a role in exporting some of the horses to Mexico's "kill plant," according a report released late Friday by the Office of Inspector General.

Tom Davis, who lives in Conejos County, just north of New Mexico's northern border, admitted during a federal investigation that he sold the wild horses after buying them from the Bureau of Land Management by the truckload, nearly 35 per load at \$10 a head.

He told investigators he made as much as 3,000 per truck load and said he figured BLM k n e w h e w a s s e n d i n g t h e m t o slaughter; between 2009 and 2012, the agency sold many of these horses at very low prices, the report points out.

Wild horses, whether they come from BLM or US Forest Service land, are protected under the Wild Free-Roaming Horses and Burro Act of 1971, and it is illegal to sell them for slaughter. Instead, the government's plan for decades has been to round up the excess horses on their range lands and then put them up for adoption, with federal agents ostensibly following up on their conditions a year later.

Fed rejects pot bank

DENVER — Colorado's attempt to create a bank to service its marijuana industry has suffered another setback by the federal government and could be facing an impossible dilemma.

The Federal Reserve — the guardian of the U.S. banking system — said in a court filing Wednesday that it doesn't intend to accept a penny connected to the sale of pot because the drug remains illegal under federal law.

The stance appears to mark a shift in the position of the federal government. Last year, the U.S. Treasury Department issued rules for how banks can accept pot money.

"We're frustrated," said Andrew Freedman, director of marijuana coordination for Colorado Gov. John Hickenlooper. "We tried to do the most with the building blocks of instructions they sent us, set up the most rigorous solution. And we still are left with confusion."

The filing came in a legal battle between the Federal Reserve and the would-be Fourth Corner Credit Union, which was set up last year to serve Colorado's \$700 million-a- year marijuana industry.

The credit union can't open without clearance from the Federal Reserve, which said in its filing



Progress Made On San Luis Cemetery

The San Luis Cemetery Steering Committee is pleased to announce that the clean-up of the cemetery has been completed. Of course, much work remains to be done, especially the rock removal. A rock stockpile has been set up outside the cemetery's north gate.

The Committee thanks Costilla County Road Supervisor, Leroy Medina and the Fire Mitigation crew for the outstanding job of trimming trees. This was followed by Clean-Up Day on Saturday, October 10, 2015, which was a big success. Twenty-nine people signed up to help clean the cemetery. The San Luis Steering Committee thanks all of those individuals for their hard work.

Next, an inventory of the entire cemetery was conducted. On Monday, October 12 and Tuesday, October 13, the cemetery was divide into regions bound by flags and string. Ten teams of two inventoried the cemetery. The committee thanks to the following datagathering volunteers: Marie Gomez, Cathy Serna, Charlie Jaquez, Jim Jaquez, Janice Medina, Marlene Vigil, Juan Trujillo, Bernadette Lucero, Marcella Pacheco, Sidney Cordova, Brother Julian, Brother Kevin, Brother Justin and Brother Peter.

The Committee has completed a draft of a cemetery map with a locator database showing where individual graves are located. The database includes names, dates, monument types, and locations of individual grave sites. The information should be available soon.

A copy will be located at the Sangre de Cristo Parish office. Those persons who are aware of unmarked graves are kindly asked to bring the information to the Sangre de Cristo Parish office, in San Luis, or call Charlie Jaquez at 672-3511. The committee will soon announce the next phase of the cemetery improvement project.

On June 30, 1930, Don Delfino Salazar, a prominent businessman in the community, issued a warranty deed to J. Henry Tihen, Bishop of Denver for 3.38 acres to be used as a cemetery, "In memory of my dear wife, Frieda M. Salazar." Today, 85 years later, the cemetery is at about 70 percent of capacity and in two or three decades, this community will use the land immediately west of the current cemetery. That property was deeded to the Sangre de Cristo Catholic Church on June 19, 1987, by J.M. (Jack) Vigil of San Diego, California. Certainly, sufficient time remains to carefully plan the next cemetery.

The San Luis Cemetery contains approximately 642 graves of which a few are unknown due to erased or weather-damaged markers or monuments. The earliest birth date found was that of Mr. Epimenio Medina who was born December 12, 1853, just two years after the Town of San Luis was established. He passed away June 13, 1940 at the age of 86.

The San Luis Cemetery Steering Committee kindly makes a request to those persons with friends or relatives buried there to "Please clean those gravesite as frequently as possible. Remove all glass, rocks and gravel. Those materials make it dangerous or impossible to mow the area. Much work remains to get the San Luis Cemetery to mower ready status."

"We want to remind the community that the cemetery has no staff only volunteers. A recent telephone message received stated, "If we all work together, we can get it done. That truly is a message that resonates. Lastly, the Steering Committee thanks Lillian Jaquez-English and Tom from Denver, Evangeline Salazar of Pueblo, Viola Mondragon of Santa Fe, Austin Gold and Sandra Berg of Denver for their monetary donations. HISTORY: CELEBRATING THE DAY OF THE DEAD

The Day of the Dead is a unique festival that is the result of 16th century contact between Mesoamerica and Europe. Conceptually, it is a hybrid, owing its origins to both prehispanic Aztec philosophy and religion and medieval European ritual practice. Ceremonies held during the Aztec summer month of Miccailhuitontli were mainly focused on the celebration of the dead. These were held under the supernatural direction of the goddess Mictecacihuatl.(1) Both children and dead ancestors were remembered and celebrated. It was also during this month that the Aztecs commemorated fallen warriors. According to Diego Duran, a 16th century Spanish priest, the Aztecs would bring offerings of food to altars in honor of the dead. They would also place small clay images that were supposed to represent the deceased on these same altars. (2)

When the Spaniards arrived in the 16th century, they brought the Christian Holiday of All Soul's Day with them. This was a Roman Catholic holy day commemorating the dead in general as well as baptized Christians who were believed to be in purgatory. Spanish priests were quick to see a correlation between the Aztec and Christian celebrations so moved the Aztec festival from summer to fall so that it coincided with All Souls Day. This was done in the hopes that the Aztec holiday, which the Spaniards considered to be pagan, would be transformed into an acceptable Christian holiday.

The result of this cultural blending is an event where modern Mexicanos celebrate their ancestors during the first two days of November, rather than at the beginning of summer. While this modern festival has Christian components, it still maintains its indigenous Native American ones.

Across Mexico, activities associated with Day of the Dead are fairly consistent from place to place. On the first day, families visit the graves of their relatives. During this time, they decorate the gravesite with flowers, earth, and candles. The also hold a kind of picnic at the graveside where they interact socially among themselves and with other families and community members who are all gathered at the cemetery. The stories that are exchanged by the families often feature other people who are also buried in the same cemetery. In this way, Day of the Dead acts as a method of social cohesion between different groups of people. Folks gathered around the graves are there not only to celebrate their ancestors, but to celebrate the role that those ancestors played in a larger community. The meals prepared for these picnics include tamales and pan de muerto (a special bread in the shape of a person). Many people believe that it is good luck to be the one who bites into the plastic toy skeleton hidden by the baker in each rounded loaf. Sweets are also included in the feast.



These include, cookies, chocolate and sugar skulls. Friends and family members exchange gifts consisting of sugar skeletons or other items with a death related iconography. Often times, a gift is more prized if the skull or skeleton has one's own name written on it with icing. As in the case of pan de muerto, when the celebrant takes a bite out of the skull, the person symbolically "takes a bite of death" and thereby, inoculates themselves against the fear of death. Decoration is not restricted to gravesites. Often times people set up home altars dedicated to the same relatives. These are profusely decorated with flowers (primarily yellow and orange marigolds and/or crysanthemums). These were called cempoa-xochitl and are a clear holdover from Pre-Columbian times. For the Aztecs, the color yellow referenced the autumn-a season when nature begins to die. The arc or arco that forms a semi-halo atop the altar is symbolic of the path taken across the heavens by the dead. As in the case of the gravesides, home altars are also adorned with religious amulets and food offerings. The foods chosen are generally those that the deceased enjoyed during his life. This can run the gamut to different kinds of fruit, to cigarettes, and alcoholic beverages. Mescal is a favorite. All in all, the altar represents a recognition of the cycle of life and death that is part of human existence. There is some slight variation in how Day of the Dead is observed in Mexico. For instance, its celebration in large cities, like Oaxaca, leans more toward the secular than the sacred. Also, foodstuffs and altar construction are, logically enough, dependent upon the natural resources of the area. Nonetheless, what seems to be maintained throughout is the remembrance of the dead and the celebration of the continuity of life and the community.

(1) This deity's name means "Lady of the Dead." She was the female counterpart of Mictlantecuhtli, the lord of the underworld.

Davis will not be prosecuted either criminally or civilly in connection with the kill, a fact that has riled wild horse advocates across the country; the case has been directly sent to the US attorney general's office in Colorado and to the district attorney's office.

As a result, BLM and the Office of Inspector General, the investigatory arm of the Health and Human Services Department, have come under fire with Friday's release of the report, which also exonerated all BLM employees of any wrong doing in selling Davis so many horses. In fact, the report points out, the employee who sold the most horses to Davis received "monetary awards" based on the number of horses she sold.

"It took more than three years for OIG to tell us what we've always known: that the BLM sold 1,795 federally protected wild horses to a known kill buyer who sold them to slaughter," Suzanne Roy, director of the American Wild Horse Preservation Campaign, wrote in an email sent to SFR. "Unfortunately, there will be no justice for these mustangs, who suffered a brutal death in Mexican slaughter plants. No one at the BLM is being held accountable for this betrayal, and Tom Davis is not being prosecuted for violating his contractual obligation to not sell the horses for slaughter."

Southwest Livestock officials were interviewed by federal investigators, although Davis claims he never sold BLM-purchased wild horses to Southwest Livestock; he claims that he sold other horses to the company.

Horse slaughter, though it existed for years in the United States, is now illegal, and BLM horses, after they are rounded up, are branded on the neck in what is referred to as freeze-brand. It's mark that USDA investigators are supposed to look for during inspections of horses that leave the state, according to the report. A USDA inspector in New Mexico, however, told federal investigators that he never visually inspected horses coming from Southwest Livestock, but only went by paperwork, assuming it was accurate and truthful.

There are thousands of wild horses that roam 10 states in the West and Southwest, and New Mexico is one of them. The US Forest Service in northern New Mexico in Rio Arriba County just last month started Aruba rounding up wild horses on its land in El Rito and Jicarilla ranger districts.

Colorado State Patrol Investigates Fatal Crash in El Paso Countv

El Paso - (Oct. 29) This morning at approximately 9:49 a.m. a Colorado State Trooper was stationary in the median of northbound I-25 near mile marker 159 working traffic enforcement. The trooper was inside of his patrol vehicle facing north when he observed a 2007 Kawasaki motorcycle traveling southbound at a high rate of speed. The trooper measured the speed of the motorcycle at 101 miles per hour with stationary RADAR. The trooper was able to turn around safely and begin traveling southbound. The trooper activated his emergency lights and siren in and attempted to catch up to the motorcycle. Prior to the trooper regaining visual contact with the motorcycle, the motorcycle attempted to take the exit at mile marker 156, Northgate Blvd. The rider failed to negotiate the right curve of the exit ramp and drove off the left side of the exit ramp striking a road sign. Upon arrival at the scene the trooper immediately began life saving measures until medical personnel arrived.

The driver of the motorcycle, Justin Aspuria, 28 of Colorado Springs was transported to Penrose Hospital where he died. Aspuria was wearing a helmet at the time of the crash.Alcohol and/or drugs are not suspected as contributing factors in the crash. This crash remains under investigation.
