OBSERVATIONS

This was a monitoring inspection of the Nichols Pit; DRMS file No. M-1981-013, operated by Nichols Gravel Pit, L.L.P. This site is located approximately 2 miles northeast of Mesa, Colorado in Mesa County. I, Stephanie Mitchell of the Colorado Division of Reclamation, Mining and Safety conducted the inspection. Mr. John Nichols of Nichols Gravel Pit accompanied me on the inspection.

This is a 67.48 acre 112c mining operation. The total affected land was estimated to be about 30 acres based on the site observations.

Boundary markers and mine identification sign were in place and in compliance with Rule 3.1.12. Mining is progressing to the east. There is an estimated 60' highwall in the pit. Fuel is being stored with adequate secondary containment.

The Operator re-sloped (3:1) and reclaimed about 2 acres north of the pit. This area has adequate revegetation establishment. There are little or no noxious weeds on site. Overall the site looks good.

No problems were noted during the inspection.
