**Re: McClane Canyon Mine (Permit No. C-1980-004)
Permit Renewal Application No. 8 (RN-8)**

Dear Sir or Madam:

The Division of Reclamation, Mining and Safety hereby issues notice, in accordance with Title 34, Article 33, Section 118, Paragraph 3, of the Colorado Revised Statutes, that on December 17, 2015, an application to renew an existing permit to conduct coal mining operations at the McClane Canyon Mine was considered complete for the purposes of filing. All review and comment periods as provided in the Colorado Surface Mining Reclamation Act and the Rules initiate from this date of filing.

McClane Canyon Mining, LLC proposes to continue underground coal mining and/or reclamation operations on land located approximately 19 miles North of Loma, Colorado. This renewal application does not propose revisions to the approved mining and reclamation plan, nor is there any proposed surface disturbance outside of the currently approved disturbance area.

The permit area is further described as follows:

Portions of Sections 3, 14, 15, 16, 21, 22, 23, 26, 27, 28, and 34, T7S, R102W, 6th PM, all in Garfield County

The above-mentioned tracts of land are shown on the following USGS 7.5 minute Quadrangle map(s): Howard Canyon.

McClane Canyon Mining, LLC has submitted an application for renewal of a valid existing permit to conduct coal mining and reclamation for its McClane Canyon Mine, Permit No. C-1980-004.



McClane Canyon Mine is an operating underground mine on land located approximately 19 miles north of Loma, Colorado along State Highway 139. The current permit will expire on July 6, 2016. McClane Canyon Mining, LLC proposes to continue underground coal mining and/or reclamation operations and the application requests successive renewal of the permit for an additional five years.

The applicant is required to publish notice in the *The Daily Sentinel* that this permit renewal application has been deemed complete. At the time of publication of this notice, the applicant is additionally required to place a copy of this application at the Mesa County Clerk and Recorder, 200 S. Spruce Street, Grand Junction, CO 81501, and at the Division office.
