Enclosed are copies of the certificates of location of the Delta No. 1 and Delta No. 2 claims at Rifle, Colorado.

As you will recall, the two claims were staked in July, 1976, at which time there was an existing unpatented mineral claim (lode claim) existing on a portion of the land claimed as the Delta No. 1. When the heirs of the owner of this claim failed to file their assessment work on or before 1 September, 1976, this lode claim became invalid. Therefore, on 1 October of 1976, we relocated the Delta No. 1 claim, to avoid any potential future questions concerning the overlap of claims. A copy of that relocation notice is also enclosed.

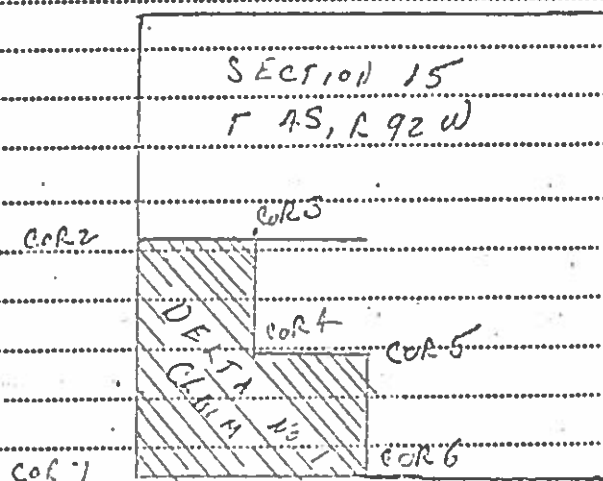

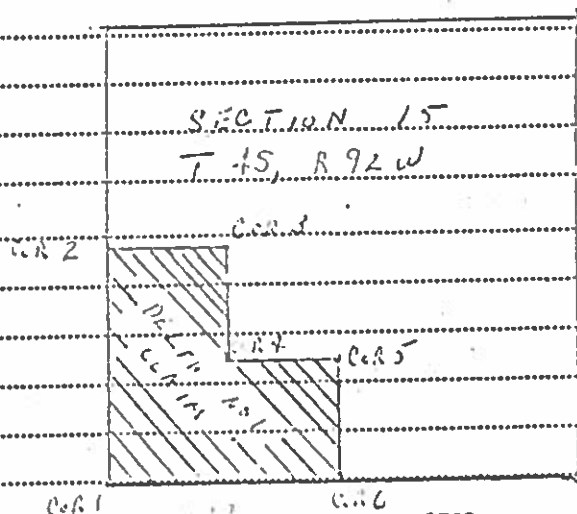
