OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Attempts were made to notify the Operator, but the phone number currently on file is no longer valid. The Operator should be reminded it is his responsibility to provide current contact information to the Division. The Operator was not present during the inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The West End Gravel Pit #1 is located approximately five miles east of Naturita and accessed from 90 Road. The site is a 112c operation that includes a total of 39.4 permitted acres. The Division currently holds a financial warranty amount of \$50,075.00 for this site.

Adequate mine identification signage was noted at the entrance to the site.

Reclamation grading has been completed and is adequate. The slopes appear stable and no erosion concerns were noted. Topsoil has been replaced, and according to the Operator's annual reports the site has been seeded. Vegetation is sparse throughout the reclamation area though and additional seeding may be required. The Division will monitor the site through routine inspections and notify the Operator whether or not additional seeding should occur.

Several gravel stockpiles remain on site in the south part of the permit area for the landowners use.

No problems or violations were noted during this inspection.
