OBSERVATIONS

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety. The East Douglas Creek mine site is located 20 miles south of Rangely, Colorado off of RBC Road No. 27. The site is a 112c operation. Clint Chappell representing Rio Blanco County accompanied the inspector(s) during the inspection.

The mine identification sign and the affected area boundary markers are in place and in compliance with rule 3.1.12. The sign is located on a post at the main entrance of the gravel mine. The permit boundaries are comprised of fence posts that are easily identifiable around the entire perimeter of the mine.

The mine is active and evidence of recent excavation was observed at the mine site. Various stockpiles of construction materials were observed within the permit area. The majority of new excavation was observed in the western portion of the permit area.

No evidence of erosion or off site damage was observed during the inspection.

No problems or violations were noted or observed during the March 16, 2016 inspection.
