LEGAL DESCRIPTION

Parcel No. 1:

A tract of land in Lot 1 of Section 5, Township 23 South, Range 52 West of the 6th P.M., described by metes and bounds as follows: From a point on the boundary line common to Section 5 and 8 of said Township which is the NW corner of Lot 1 of Section 8, thence East 195 feet to the True Point of Beginning; thence East 405 feet to a point, thence North 323 feet to a point; thence West 405 feet to a point; thence South to the True Point of Beginning.

Parcel No. 2:

A tract of land in Lot One (1) of Section Five (5), Township Twenty-three (23) South, Range Fifty-two (52) West of the 6th P.M., described by metes and bounds as follows: From a point on boundary line to Sections Five (5) and Eight (8) of said Township which is the Northwest corner of Lot 1 of said Section 8, thence East 50 feet for a Point of Beginning and thence East an additional 145 feet to a point; thence North 336 feet to a point; thence Westerly to a point 400 feet North of the Point of Beginning and at right angles to the North South course just described 145 feet; thence South 400 feet to the Point of Beginning.
