Dear Mr. O'Donnell:

Thank you for providing the opportunity to comment on the proposed application to conduct surface extraction of construction materials, (sand, gravel, road base) for the town of La Veta located NW of La Veta and further described by the following legal description; Section 7, Township 29S, Range 68W, NE1/4SE1/4, Huerfano County, CO.

As requested District Wildlife Manager Mike Brown reviewed the application and maps and conducted a site visit on 04/21/2016. Furthermore, Colorado Parks & Wildlife biologists were also consulted on the project.

The proposed 9.75 acre surface mining operation is located on private land within a short grass prairie type of habitat in close proximity to U.S. Hwy. 160. The dominant grass species consist of grama, and western wheatgrass. Additional sub-dominant grasses include buffalo grass, squirrel tail, and side oats grama. The proposed mining location is located in an area with a high degree of wildlife diversity.

The following list of species may be found throughout the area: Elk, Mule Deer, Pronghorn, Black Bear, Mountain Lion, Coyote, Swift Fox, Bobcat, Cottontail Rabbit, Jack Rabbit, Red Fox, Red-Tailed Hawk, Ferruginous Hawk, American Kestrel.



The impacts from the proposed surface material mining of sand and gravel may be characterized as minimal with no significant impacts. The proposed mining activity should have little long term effects on resident species due to the quality of habitat being impacted. To our knowledge there are no known threatened or endangered species in the exact area of the proposed mining activity. Additionally, the project will not affect any aquatic species or wetlands. During the site visit to the mine location, no raptor nests and or prairie dog towns were observed within the immediate vicinity.

In areas where ground disturbing activities are anticipated, CPW recommends reclamation with native grass and/or plant species. Proper reclamation, from a wildlife perspective, involves both soil stabilization and ground cover establishment. Reclamation seed mixes should be suited for on-site soil types and mirror both existing and native plant communities. Specific seed mixtures may be specified and or obtained by the Natural Resources Conservation Service (USDA).

A thorough noxious weed control program is also essential in proper reclamation to prevent disturbed areas from being invaded by non-native vegetation that can be detrimental to existing wildlife habitat. This may be achieved via a noxious weed management plan.
