OBSERVATIONS

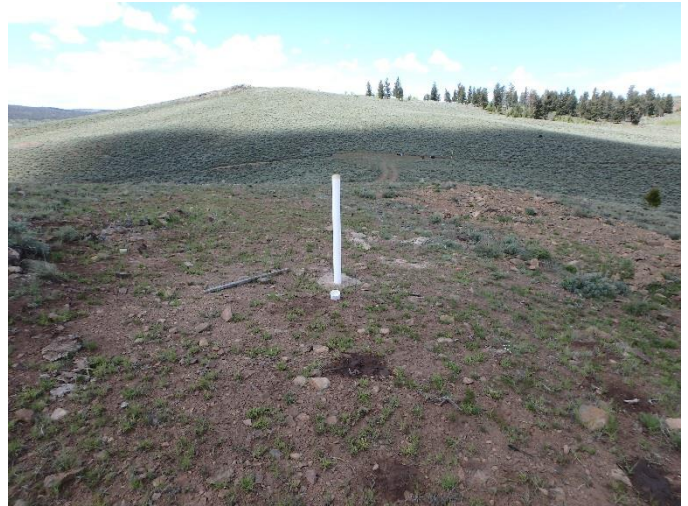
This was a surety release inspection. Steve Crittendon, representing the Operator, was present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The Iris project included two boreholes on private land located near the historic Iris townsite. The drilling occurred on pre-existing roads. This inspection verified that reclamation has been adequately completed and that the holes have been backfilled and capped in accordance with the approved reclamation requirements

No problems or violations were noted during this inspection.
