Please be advised that the undersigned, Arnold's Custom Seeding, LLC, (The Operator), pursuant to the above referenced FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER, represents the following:

- 1.) The Operator has CEASED AND DESISITED from any further mining related activity on the affected lands, described as Arnold Pit #1, subject to the exceptions noted in the FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER; and will continue to CEASE AND DESIST until all violations have been resolved to the satisfaction of the Division and the Board.
- 2.) The Operator is preparing its 110 Construction Materials reclamation permit to encompass the affected land and additional lands affected, up to 9.99 acres. Further, this application will be submitted within 30 days of June 6, 2016.
- 3.) The Operator has included a check, with this correspondence, for the amount of \$1,000.00, which is for payment of the non-suspended civil penalty imposed by the FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER.
