6.4.1 Exhibit A Legal Description

Fremont Paving's 44th Lane Project is located in eastern Pueblo County, Colorado, within the Pueblo County 2016 Gravel Crushing Project Area #2 (Figure follows). The mine area will be accessed by two private haul roads in order to minimize impact to county roads. The haul road construction design is included in Exhibit D.
