OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program. The Refuge Pit #1 is a 112c permitted site that includes a total of 43.4 permitted acres. It is located approximately 53 miles northwest of Maybell, CO and is accessed from Hwy 318. This site is on Bureau of Land Management (BLM) land. The BLM was contacted prior to this inspection but no representative was present. Billy Mack represented Moffat County and accompanied Amy Yeldell of the Division on the inspection.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The sign is located at the entrance of the permit boundary. T-posts have been placed to clearly delineate permit boundaries.

The site was inactive at the time of inspection but well maintained. No structures, equipment or fuel were observed on site. The earthen berm lined containment remains in place. No stockpiles were observed. Overburden has been stripped from the next mining area. The overburden and topsoil piles are well vegetated and stable. The topsoil and overburden piles are clearly marked with signage to prevent accidental loss.

This spring a portion of the "original" pit was reclaimed and seeded. No germination in the reclaimed areas was observed. The pit floor was not seeded to allow for future stockpile storage. All reclaimed slopes have been properly graded to a 3:1 or less and are stable.

Little to no weeds were observed. This spring was abnormally wet making any treatments difficult to impossible. The operator is encouraged to resume weed treatments on an as needed basis as weather conditions allow.

This site is operated by a government agency and therefore no bond is held by the Division. No problems or violations were noted during this inspection.
