OBSERVATIONS

This inspection was conducted as part of the Colorado Division of Reclamation, Mining and Safety normal monitoring program. The Clay Pit No. 21 is a 112c permitted site that includes a total of 18.5 permitted acres. It is located approximately 20 miles northwest of Maybell, CO and is accessed from Moffat County Road 20. This site is on Bureau of Land Management (BLM) land. The BLM was contacted prior to this inspection but no representative was present. Billy Mack and Linda DeRose represented Moffat County and accompanied Amy Yeldell of the Division on the inspection.

The mine identification sign and affected area boundary markers are in place and in compliance with Rule 3.1.12. The sign is located at the entrance of the permit boundary. T-posts have been placed to clearly delineate permit boundaries. Also the permit boundary has been brush hogged.

A front end loader was on site and it was indicated that activity took place earlier this spring. No fuel is stored on site. The earthen berm lined containment remains in place. No structures have been erected at this site.

Two stockpiles were observed on the pit floor. Stockpiles are sloped approximately 2:1 and stable. No crushing or screening of material occurs at this site. Material is excavated and trucked to the Little Snake Pit # 26 (M-1999-048) where it mixed with that material. All pit slopes appear to be graded to approximately 3:1. The pit floor has been mined to a depth of approximately 10'.

The overburden and topsoil piles are well vegetated and stable. The topsoil and overburden piles are clearly marked with signage to prevent accidental loss. No erosion was observed.

Little to no weeds were observed. This spring was abnormally wet making any treatments difficult to impossible. The operator is encouraged to resume weed treatments on an ass needed basis as weather conditions allow.

This site is operated by a government agency and therefore no bond is held by the Division.

No problems or violations were noted during this inspection.
