OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. Jim Sheridan, representing the Operator; Ed Cotter, Kyle Turley, Russel Edge, Brian Mangan and Nicole Olin, representing DOE; Dustin Czapla and Russ Means, representing the Division of Reclamation, Mining and Safety; were present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The JD-9 Mine is located approximately twelve miles west Naturita and accessed from FF16 road. The site is a 112d-1 operation that includes a total of 11.1 permitted acres.

No evidence of recent mining activity was noted during this inspection. The site is currently in Temporary Cessation. Only general site maintenance and housekeeping have taken place at the site since the Division's last inspection.

Upper Monogram area

Vent fans and water treatment plant are located in this area. The water treatment plant is not currently in use. Treatment ponds were dry during the inspection. Facilities in this area appeared secure.

Bull Canyon area

Unused equipment and the empty fuel tank have been removed from the Bull Canyon area. There is a mine building located on the main mine bench area. The portal in this area collapsed years ago and has not yet been reopened.

Adequate mine identification signage was noted at the entrance to the site.

No problems or violations were noted during this inspection.
