In accordance with C.R.S. 34-32.5-117 (1) and Rule 4.1 (2) of the Rules for the Extraction of Construction Materials the decision to approve the application shall be reconsidered by the Mined Land Reclamation Board. The re-notice procedures have been completed in accordance with C.R.S. 34-32.5-112(9) (c) and Rule 1.6.2 (1) (e) of the Rules for the Extraction of Construction Materials. No comments or objections were received. The operator has submitted the Performance Warranty and the required Financial Warranty in the amount of **\$225,851.57**. Division review of the documents finds them complete and acceptable. Staff recommends that the Board reaffirm the approval of the application M-2015-001 for the new 112 (c) permit and direct the Division to issue the permit.
