Dear Mr. Smith,

The Division received Terror Creek, LLC's application for a minor revision (MR-29) on August 19, 2016. The application was determined to be complete on August 25, 2016. The Colorado Division of Reclamation, Mining and Safety completed its preliminary adequacy review of the proposed revision in a letter dated August 25, 2016. Responses to the Division's adequacy comments were received by the Division via email on October 10, 2016.

Division's initial comment: 1. Based on a review of the ownership and control section of the currently approved permit application pacage for the Terror Creek Loadout, comparing the section, along with the proposed updated information submitted with MR-29, with the current information in the Applicant Violator System (AVS), there are descrepancies that will need to be addressed by Terror Creek, LLC. Please address the following deiscrepancies listed below:

- a. Please provide end dates for the following people listed on the Directors/Officer report: Joseph Micheal Smith, assistant secretary and Jeffrey Wadman, senior vice president and corporate officer
- b. Please provide an updated diagram of the organizational structure per Rule 2.03.4(3)(b).

In response to the Division's preliminary adequacy comment number 1, Terror Creek, LLC submitted additional information regarding ownership and control. Based on the responses from Terror Creek, the Division understands that Oxbow US Coal LLC merged into Oxbow Mining, LLC on March 31, 2015 and Terror Creek LLC was dissolved and merged into Oxbow Mining, LLC on May 8, 2016. Due to a change in the permittee name an Succession of Operators application is warrented.

Due to a required Succession of Operators application, the Division requests the following information be submitted with the SO-1 application:

- 1. Update any other ownership percentage change between companies (other than OCMH now owns 58% of OC).
- 2. Provide board resolution for the dissolution of Terror Creek, LLC. and transition to Oxbow Mining, LLC as permittee.
