Pleasure talking with you today. I have much to learn and you were very informative.

Per the inspection report for the Suzanne Marie mine, permit #M-2009-093, in Larimer County, CO, a visit was made to the Suzanne Marie mine on Sunday, October 16, 2016 by myself and my grandson, Gunnar Travis, to address the issues cited on the report dated August 19, 2016 (inspection date). I have attached the following documents:

Inspection Topic #1: Availability of Records(business registration):

- Business registration updated October 10, 2016

Inspection Topic #2: Gen. Compliance With Mine Plan (trash removal):

- My grandson and I moved the usable aluminum sheets, timbers and wood blocking to the trailer located on site, stacked all items and secured them.

The trailer and this material is not visible from the road.

All noon-mining related or usable materials were removed from the site and disposed of.

- Pictures of the trailer, trailer from the road and cleaned up site attached (2 of 3 are attached to separate emails due to doc size)

Inspection Topic #3: Signs and Markings (posting of operator/permit and boundary markings):

- We posted a sign (visible from the road) with the operator name (Theisen Mineral) and Permit number (M-2009-093) that is visible from the road.

We would like to request an extension on marking the mine boundaries as we were unable to accurately accomplish this at the site visit October 16, 2016. The boundaries will be located and visibly marked no later than June 15, 2017.

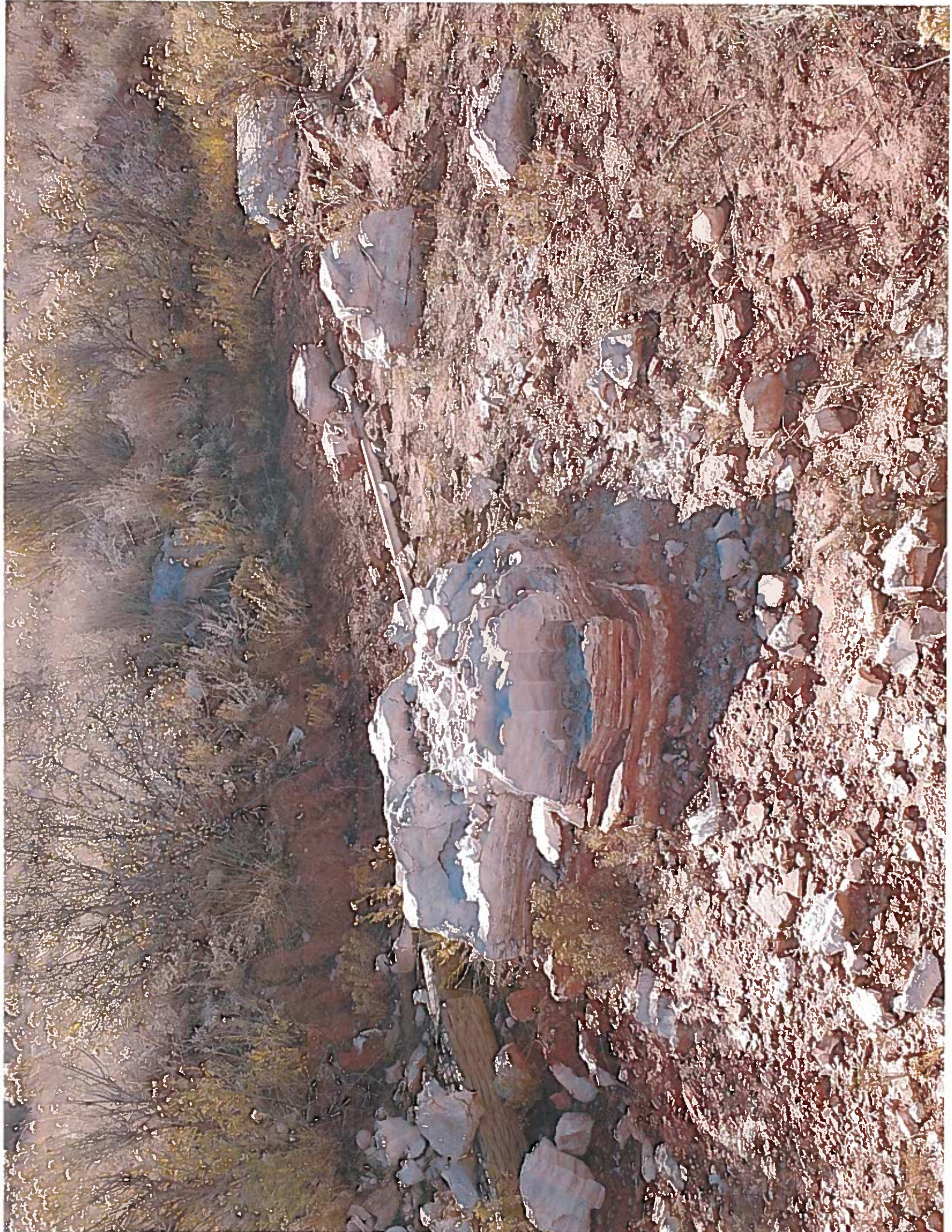

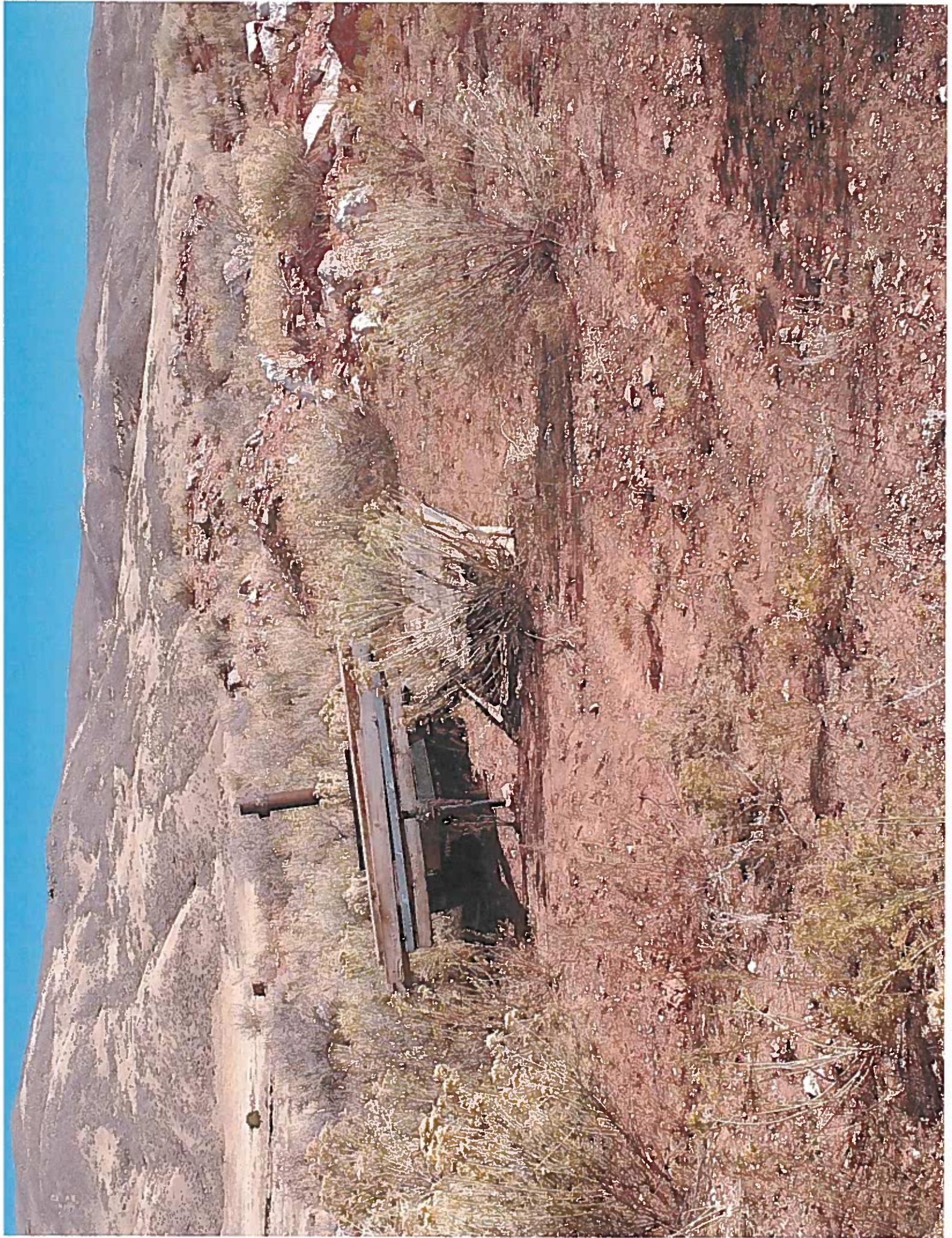
