On January 6, 2017 the Division issued a Proposed Decision to WITHDRAW Technical Revision No. 110 (TR-110) associated with the Bowie No. 2 Mine (C-1996-083). This Proposed Decision was based on a request by the applicant, Bowie Resources, LLC, to withdraw the application. The Division understands that you have requested a Public Hearing in regard to TR-110. Due to the Proposed Decision to withdraw, the Division will no longer be scheduling a Public Hearing on the application. The Proposed Decision to withdraw was published in the Delta County Independent on January 11, 2017 and a 10-day public comment period was initiated from that date. The Final Decision to Withdraw will fall on January 23, 2017. Thank you for your interest in Technical Revision No. 110 (TR-110).
