OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. The operator was not contacted prior to this inspection, so a representative for the operator was not present. Photographs are included with this report in order to illustrate some of the conditions observed.

The Grizzly Ridge Pit is located approximately six miles south of Crawford and accessed from Black Canyon Road. The site is a 110c operation that includes a total of 9.9 permitted acres.

Adequate mine identification signage was noted at the entrance to the site.

The affected area was marked by posts and signs that were clearly visible and adequate to delineate the affected area boundary.

There was no mining activity occurring or personnel at the site during this inspection. The site is well maintained. The mine face was left at an approximate 2H:1V slope. No rilling was observed on the slope. A stockpile of gravel was located on the pit floor. Adequate topsoil was stockpiled on the south side of the mine bench. The stockpile was stabilized with adequate vegetation. Noxious weeds were not observed.

No problems or violations were noted during this inspection.
