
We received your correspondence dated February 18, 2017 on February 24, 2017 initiating consultation with our office under the State Register of Historic Places Act (CRS 24-80-1 et seq.) for the above referenced undertaking.

A search of our database indicates that no cultural resource inventory has been conducted within the proposed permit area. A historic transmission line segment, 5MI-7572.1 has been recorded in the southern portion of the permit area. The entire resource has been officially determined to not be eligible for the State or National Register of Historic Places.

As most of Colorado has not been inventoried for cultural resources, our files contain incomplete information. Consequently there is the possibility that as yet unidentified cultural resources exist within the proposed permit area. The requirements under CRS 24-80 part 13 apply and must be followed if human remains are discovered during ground disturbing activities.
