The Division has completed its review of the above referenced report received on 14 February 2017. The Division finds the 2016 Annual Reclamation Report in compliance of the following Rules:

Rule 2.04.13(1) - Received 14 February 2017. The Annual Reclamation Report is required to be received by the Division by February 15. No other date for submittal has been approved by the Division.

Rule 2.04.13(1)(a) - The cover of the ARR includes the name of the permittee, the address, and the permit number.

Rule 2.04.13(1)(b) - The ARR identifies 0.20 disturbed acres disturbed during calendar year 2016.

> The Last Years cumulative total of Acres Backfilled and Graded; and Acres Topsoiled identified in the 2016 ARR is 152.20. However, the Cumulative Total of the 2015 ARR identifies 152.68 Acres backfilled and graded; and acres topsoiled. It appears that the number used in the 2016 ARR for "Last Years Cumulative Total should be 152.68. Please address why the two totals are different.
