OBSERVATIONS

This inspection was conducted as part of the Division of Reclamation, Mining and Safety's (Division) normal monitoring program. A representative for the operator was not present during this inspection. Photographs are included with this report in order to illustrate some of the conditions observed.

The Gray Pit #2 is located approximately eight miles east of Montrose with access from Kinikinik and Miguel roads. The site is a 112c operation that includes a total of 39.74 permitted acres. The Division currently holds a financial warranty amount of \$16,500.00 for this site. The Division has reviewed the reclamation costs, in order to ensure the financial warranty reflects the actual current cost of fulfilling the requirements of the Reclamation Plan, and determined that the current financial warranty amount is adequate at this time.

A mine identification sign was not noted at the entrance to the site. Since the operation has not yet commenced, this is not considered a problem at this time.

Mining has not yet commenced at this site. Some minor clearing has occurred in the Phase 1 area, but disturbance is minimal. There has been no mining activity since the Division's last inspection.

No problems or violations were noted during this inspection.
