OBSERVATIONS

This inspection was conducted as part of the normal monitoring program established by the Colorado Division of Reclamation, Mining and Safety (DRMS). The Berry Pit is located approximately 1 mile east of Meeker, Colorado. The site is a 112c operation which consists of a 91.21 acre permit area with a maximum allowed disturbance of 67.6 acres. According to DRMS records the sight has not been inspected since May 2011.

The mine identification sign was observed at the main entrance to the site along with permit boundary markers in the form of "t-posts" with signs. Both the mine identification sign and permit boundaries are in compliance with Rule 3.1.12.

The site was inactive during the inspection and only a few pieces of equipment were observed within the permit area. An asphalt plant was observed in the permit area. Evidence of recent excavation was observed in the eastern portion of the pit that is likely Phase 6. All fuel and chemical tanks were properly placed in secondary containment. Various stockpiles of processed material were observed within the permit area.

In an effort to ensure that the financial warranty remains adequate to reclaim the site per the requirements of the approved reclamation plan, DRMS will re-calculate the reclamation cost estimate which will be sent under separate cover. Therefore pursuant to Sections 34-32.5-117(4) of the Colorado Land Reclamation Act, adequate financial warranty must be submitted to the DRMS within 60 days of the mailing date upon receipt of the surety update letter.

No off-site damage was observed and no problems or possible violations were noted during this inspection. The only minor issue of concern was a "porta-poddy" that was laying on its side that was likely overturned by a windy storm event.
