The Division has completed its review of the above referenced report received on 22 March 2017. The Division finds the 2016 Annual Reclamation Report in compliance of the following Rules:

Rule 2.04.13(1) - Received 22 March 2017. The Annual Reclamation Report is required to be received by the Division by February 15. As a permit requirement the HG Loadout ARR is required to be submitted to the Division by March 30.

Rule 2.04.13(1)(a) - The cover of the ARR includes the name of the permittee, the address, and the permit number.
