### PUBLIC NOTICE

Elk Ridge Mining and Reclamation, LLC, P.O. Box 628, Nucla, CO 81424 has filed with the Division of Reclamation, Mining and Safety an application for a Technical Revision 79 (TR-79) to the New Horizon Mine Permit No. C-1981-008. TR-79 proposes to add 2.45 acres of adjacent support facilities area to the permit to allow for movement of topsoil piles 11A & 11B from Elk Ridge Mining and Reclamation property to Slash M, LLC property.

The New Horizon Mine office is located at 27646 West 5th Street, P.O. Box 628, Nucla, Colorado.
