Attached is the Division's estimate associated with the activities proposed under TR-79 at the New Horizon Mine. The costs represent the relocation of the topsoil used to repair areas on the Morgan property from the current location to the southern end of the Morgan property. The length of travel was measured at ~8,100 ft and involved the relocation of 9,570 cy of topsoil.
