Elliott,

As requested in the May 13, 2014 DRMS Inspection Report for Transit Mix's Pueblo East Pit, attached is updated water level data for the northern Phase 2 area of the Pueblo East Pit, including measurements of nearby residential wells on 25th Lane. Wells that are currently being measured in the area include Transit Mix's monitoring wells MW-4R and MW-105, as wells as residential wells Mraovich (2 wells), Rael, Winters, Luczak, Cooper, Jackson, Moore, and Baker. Residential wells are measured when possible.

We note that the inspection report also requested water level measurements from Transit Mix wells MW-4, MW-5, MW-6, and MW7. Except for MW-4, these wells have been mined out and well abandonment forms (GWS-09) have been submitted to the DWR. MW-4 is currently inaccessible and cannot be measured at this time.

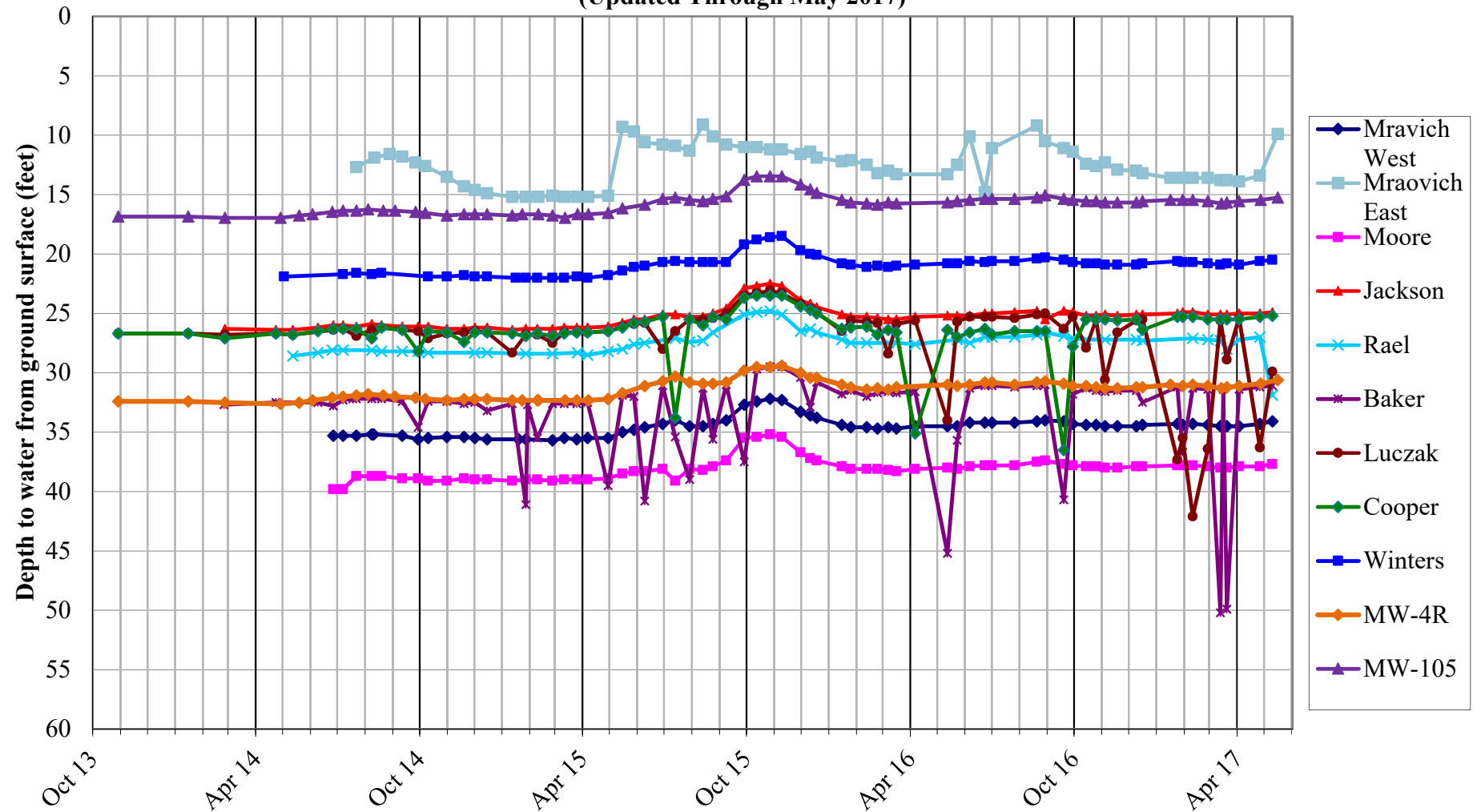
