

Resolution: Daniel J. Gaudreault and Barbara J. Gaudreault (Operator), concedes to the violation of C.R.S. 34-32.5-109(1), for failing to first obtain a reclamation permit from the Mined Land Reclamation Board before engaging in a new mining operation; and to the Cease-and-Desist Order, Corrective Actions, and Civil Penaltics provided herein, for the Big "G" Gravel Pit, Permit No. M-2006-081.

## Chronology:

- March 1, 2017 DRMS site inspection, report signed and mailed April 4, 2017
- April 4, 2017 RTB signed and mailed to Operator
- May 25, 2017 Notice of Continuance sent to Operator following Operator's request to continue

Reason for Violation: As detailed in the Division's inspection report, signed April 4, 2017, the mining operation has affected approximately 7.3 acres outside of the approved permit boundary. The Division considers mining more than two acres outside of the approved permit boundary as a violation for mining without a permit and thus the Operator failed to first obtain a reclamation permit from the Mined Land Reclamation Board before engaging in a new mining operation.

## Staff Recommendation:

Violation: Find a violation of C.R.S. 34-32.5-109(1) for failure to first obtain a reclamation permit from the Mined Land Reclamation Board before engaging in a new mining operation.

Cease and Desist Order: Issue a Cease and Desist Order prohibiting any further activities outside of the approved permit boundary, with the exception of the access road and those activities approved by the Division, in writing, until corrective actions have been resolved to the satisfaction of the Division and the MLRB.

Corrective Actions: Require the Operator to file an amendment application to increase the size of the current 112c Reclamation Permit to include the affected lands outside of the approved permit boundary. The Operator shall file a complete amendment application within 90 days of the mailing date of the Board Order, with all material in an approvable form within statutory deadlines of the mailing date of the Board Order.

Civil Penalty: Pursuant to C.R.S. § 34–32.5–123(2) an operator who operates without a permit shall be subject to a civil penalty of not less than \$1,000.00 per day, nor more than \$5,000.00 per day for each day during which such violation occurs. In this case, there are 50 days of violation from the signature date of the RTB letter (April 4, 2017) to the originally scheduled May 24, 2017 Board Meeting; the Board may assess a civil penalty of \$50,000.00 to \$250,000.00.

The Board will assess a civil penalty of \$1,000.00 per day of violation for 50 days, for a civil penalty amount of \$50,000.00 with all but \$1,000.00 suspended if the Operator complies with the corrective actions.

The portion of the civil penalty not suspended, \$1,000.00, shall be due and payable within thirty (30) days of the effective date of the Board Order. If the Operator does not comply with the corrective actions set forth in the Order, then the suspended penaltics, \$49,000.00, shall be due and payable. Failure to submit any due and unpaid civil penalties shall result in immediate submittal of such penalties to State collections.
