**RE: Mineral Joe Claims, No. M1977284, Status of Permit, Temporary Cessation.**

Dear Mr. Pottorff,

On May 7, 2013 the Mined Land Reclamation Board signed a board order approving Cotter Corporation's (Cotter) request to put several permits into an initial Temporary Cessation (TC) pursuant to Rule 1.13.5(1)(a) for five (5) years (see attached). Per the request the TC was effective December 15, 2012.

Division records and inspections indicate a lack of mining operations or other activities which are defined in Rule 1.13.2: "Indications of Temporary Cessation" for the above referenced site. The Mineral Joe Claims provides access to, and is directly associated with, the JD-6 Mine which is one of the permitted sites referenced in the 2013 board order and currently in TC. As a result of this association, the Mineral Joe Claims permit should have been included in the original TC notices effective December 15, 2012.

Therefore, Cotter must request a Temporary Cessation with retro-active effective date of December 15, 2012 to bring it into line with the JD-6 Mine TC. If Cotter does not agree with this assessment the Division is requesting detailed documentation of mining operations and production that have occurred at these locations since December 15, 2012 by August 1, 2017.

Failure submit a TC request with an effective date of December 15, 2012 for the Mineral Joe or submit the information on mining operations and production will require the Division to bring the matter before the Board under Rule 1.13.8(2) to establish the commencement date via Board Order.

Please note and be aware of the initial five year time limit notice for TC sent to Cotter by the Division. The Mineral Joe permit must address the second TC issue in similar fashion in regard to upcoming deadlines and requirements that are due December 1, 2017 for the JD-6 Mine.
